Sponsor/Beneficiary	Name : The beneficiary of the project is "ABC Inc." (ABC), a non-profit organization incorporated under the laws of the State of Ohio with the primary objective of serving the growing Muslim population in Ohio.
	Status and Objectives: ABC is a non-profit, tax-exempt organization formed in 2004 exclusively for educational, religious and social purposes. It was established to serve the growing Muslim community in Ohio. It is registered with the Internal Revenue Service under revenue code 501(c) (3). It is a multi-ethnic, multi-racial, multi-lingual, non-sectarian, diverse and open community committed to full and equal participation and involvement of men and women who are community members and who subscribe to accept ABC rules, regulations and procedures.
	 Activities: To establish and maintain an Islamic Center, Library, School, Outreach, and Youth Activity Center. To contribute to the society at large through Outreach and Social Service. To bring the community together by providing services, via congregational prayers; and educational, spiritual and counselling services to the community through Sunday school, summer school, evening classes, after-school programs, and educational seminars.

	This project entails the construction of multiple mixed-use commercial office spaces. The total built-up area of the project is approximately 9,000 square meters.
