1. The People's Republic of Bangladesh has received financing from the Islamic Development Bank (IsDB) towards the cost of Urban Water Supply and Sanitation in 23 Pourashavas Project in Bangladesh. It is intended that part of the proceeds of this financing will be applied to eligible payments under the contract for DOHR-W3.

The Executive Engineer, DPHE, Dhaka Division, Dhaka, Bangladesh now invites sealed bids from eligible bidders for the Construction /Installation of 4 Test Tube-wells, 2 Production Tube-well, 3 Pump houses, Submersible Pump Procurement with Column Pipe, Electric Panel Board Installation etc., electrification with transformer 80 Water points, 1 Ground Water Treatment Plant and 1 overhead tank under "Urban Water Supply and Sanitation in 23 Pourashavas Project in Bangladesh"("the Works"). The works will be implemented in Dohar Pourashava of Dhaka District, Bangladesh.

Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in IsDB's Guidelines: Procurement of Goods, Works and related services under Islamic Development Bank Project Financing, April 2019 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines.
