1. The *Republic of Maldives* has received financing from the Islamic Development Bank (IsDB) toward the cost of the *Strategic Preparedness and Response Program for COVID-19 pandemic*, and intends to apply part of the proceeds toward payments under the contract for Procurement of ICT Equipment.
2. The *Ministry of Finance* on behalf of Ministry of Health (the Employer) now invites sealed bids from eligible bidders for *Procurement of ICT equipment which includes Servers, SAN (Storage array), Firewall, UPS, Core switch, Desktop Computers, Laptops, Printers, Tablets, Cooling System and Video Conference System*.
3. Bidding will be conducted through *the National Competitive Bidding (NCB)* procedures as specified in IsDB's *Guidelines: Procurement of Goods, Works and related services under Islamic Development Bank Project Financing April 2019* ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.18 -21 setting forth IsDB's policy on conflict of interest.
4. Interested eligible bidders may obtain further information from *Ministry of Finance*, and any clarifications may be sent to the *address in Paragraph 9* below on or before 14:00:00 hrs, February 15, 2023.

The interested eligible Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of MVR 500.00 (Maldivian Rufiyaa Five Hundred), for the procurement from *February 2, 2023 to February 21, 2023* by: (a) payment of a non-refundable Registration fee of MVR 500.00 (Maldivian Rufiyaa Five Hundred), through our online payment portal - Ban'deyri Pay (<https://bandeyripay.finance.gov.mv/>) and, (b) e-mailing the following information to the below given e-mail addresses:
