1. The Government of the Republic of Cameroon *has requested* funding from the Islamic Development Bank to cover the financing of **the Douala – Bafoussam road rehabilitation project (218.9 km)**. To this end, it intends to use part of the funds for eligible payments under the consultant services contract for which this call for expression of interest is issued.
2. The services include control and supervision of the Douala - Bafoussam road rehabilitation works in three lots; Lot 1: Bekoko-Penja (70 km); Lot 2: Penja – Nkam Bridge (77.7 km) and lot 3: Nkam bridge – Bandjoun (71.2 km). The Consultant will be in charge of the following services:
  - **Mission 1. (WEM):** Works Contract Execution Management;
  - **Mission 2. (SMC):** Scheduling, Management and Coordination of work site;
  - **Mission 3. (AAO):** Assistance to Acceptance Operations.
3. The services shall be provided within 49 months, for a total of 4,517 H/month (supervisory, short-term, execution monitoring and support staff).
4. Clearly defined Terms of reference (ToR) for this mission can be obtained at the Joint Financing Road Projects Unit (JF-RPU) in the Ministry of Public Works.
5. The Minister of Public Works hereby invites eligible consulting firms (Consultants) to express their interest in providing these services. Interested consultants must provide specific information showing that they are fully qualified to carry out these services (booklets, description of similar projects, experience acquired under similar conditions, list of qualified personnel for the mission, etc.).
6. To apply, each Consultant (firm) must meet the following qualification criteria:
  - ❖ General experience in the field of supervision and control of road rehabilitation or construction works during the last ten (10) years (2015 - 2025);

- ❖ Have carried out at least three missions with donors (IsDB, World Bank or AfDB...) in the field of supervision and control of road rehabilitation or construction works of a minimum linear length of 50 km during the last ten (10) years (2015 - 2025);
- ❖ Have carried out at least one mission with donors (IsDB, World Bank or AfDB...) in the field of control and supervision of road rehabilitation or construction works of a minimum linear length of 50 km in Sub-Saharan Africa during the last ten (10) years (2015 - 2025).

**NB:** The Consultant must provide in his expression of interest file for each project, proof of references in terms of contracts already successfully completed or ongoing (1st page, 2nd page, contract signed pages, technical acceptance report of the final phase or certificate of good completion).

7. Interested individual consultants are invited to read Clauses 1.12.1 and 1.12.2 of the IsDB Guidelines for Procurement of Consultancy Services under Projects Financed by the Islamic Development Bank (the "Procurement Guidelines") which set out the IsDB's policies on conflicts of interest.
8. Consultants may associate to increase their chances of qualification, but must clearly indicate whether the association takes the form of a consortium or sub-contracting. In the case of a consortium, all the partners in the consortium are jointly and severally liable for the entire contract, if they are selected.
9. A consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method, from the short-listed firms, as set out in the Procurement Guidelines.
10. Interested Consultants may obtain further information at the address below, during working hours: between 9:00 a.m. and 3:00 p.m.
11. Expressions of interest shall be sent by e-mail or submitted at the address below no later than **16 DEC 2025**, at 3:30 p.m. local time and shall bear the following : "Expression of Interest for the Recruitment of a Consultant for the Control and Supervision of the Douala-Bafoussam Road Rehabilitation Works in Three Lots; Lot 1: Bekoko - Penja (70 km); Lot 2: Penja – Nkam Bridge (77,7 km), Lot 3 (71.2 km)." Late application files shall be rejected.
