- Provide details of upto Three (03) relevant projects completed in the last ten years. These should illustrate the technical capability of the entity or consortium in executing similar assignments.
- Provide at least Two (02) Environmental Assessments (SESA/SIAs/IEEs) conducted for national highways or expressways,
- Provide at least (1) assessment prepared in compliance with requirements of an international lender (e.g., IsDB/WB/ADB/AIIB),
- Provide at least (1) project undertaken in climate-vulnerable terrain (e.g., flood-prone, coastal areas).
- The Consultant must demonstrate mandatory and proven experience up to 02 projects in social safeguards including preparation of the following instruments under IFIs frameworks:
  - Resettlement Action Plans (RAPs)
  - Social Impact Assessments (SIAs) and Social Due Diligence Reports (DDR)
  - Labour Management Plan (LMP)
  - Stakeholder Engagement Plans (SEP)
  - Other Social Safeguard instruments

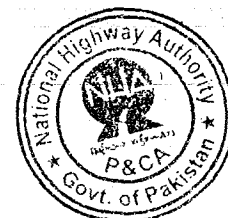
