The Republic of Mozambique has received Finance from the Islamic Development Bank (ISDB) and the OPEC Fund for International Development (OPEC Fund) toward the cost of the Temane Transmission Line Project and it intends to apply part of the proceeds of this financing to payments under the Contract for:

LOT 5 - Plant, Design, Supply & Installation of 340kms of 400 kV Single Circuit Transmission Line from the Vilanculos Substation to Chibuto Substation

Bidders may also bid for the following Lot which will be the subject of a separate and concurrent RFB:

LOT 6 - Plant, Design, Supply & Installation of 176 km of 400 kV Single Circuit Transmission Line from Chibuto Substation to Matalane Substation and Construction of 43 km, 400 kV Single Circuit Transmission Line from Matalane Substation to Maputo Substation which will be issued on the World Bank website under RFB Reference No.: TREP-P160427-RFB6(P)/Lot 6.

Each Lot shall be evaluated separately and minimum qualification requirements for combined contract(s) shall be the aggregate qualification requirements for each contract for which the Bidder submitted a Bid.

SNTE – Sociedade Nacional de Transporte de Energia, S.A. (wholly owned subsidiary entity of Electricidade de Moçambique, EP) now invites sealed bids from eligible bidders for:

Design, supply and construction of approximately 340 km, 400 kV Single Circuit (SC) Transmission Line from Vilanculos Substation to Chibuto Substation, with bundled 4 x Tern conductor, one OPGW and a second shield wire ACS on self-supporting Y-shape tension towers and guyed V or self-supporting steel lattice towers. The contract is required to be complete within a period of 30.5 months. (Lot 5).

3. Bidding will be conducted through *Open International Competitive Bidding (ICB Open)* procedures as specified in IsDB's <u>Guidelines: Procurement of Goods, Works and related services under Islamic Development Bank Project Financing April 2019</u> ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.18 -21 setting forth IsDB's policy on conflict of interest.

The Bidding procedure will be single-stage with single envelop bidding, ICB Open with Post Qualification.
