Electricidade de Moçambique (EDM) has received financing in the amount of USD 99,7 million (ninety nine million and seven hundred thousand United States Dollars) equivalent from the Islamic Development Bank toward the cost of the Temane Transmission Project (TTP) for Regional Transmission Development Project (Phase 1), and it intends to apply part of the proceeds to payments for goods, works, related services and consulting services to be procured under this project. This project will be jointly financed by the OPEC Fund for International Development (OFID).

The project will include the following components:

- **Works:** (i) 400 kV Line between Vilanculos and Chibuto comprising 1 lot of 400 kV transmission lines (Procurement mode: ICB Open).
- **Services:** Project Financial Audit (Procurement mode: LCS National Shortlist), Individual Consultants (Advisory) (Procurement mode: IC International Shortlist) and Capacity Building and Training (Procurement mode: SSS).
- **Goods:** Equipment of Project Implementation Unit (PIU), PIU Vehicles and IT Equipment (Procurement mode: National Shopping).

Procurement of contracts financed by the Islamic Development Bank will be conducted through the procedures as specified in the Guidelines for Procurement of Goods, Works and related services under Islamic Development Bank Project Financing (April 2019), and is open to all eligible bidders as defined in the guidelines. Consulting services will be selected in accordance with the Guidelines for the Procurement of Consultant Services under IsDB Project Financing (April 2019)

Specific procurement notices for contracts to be bid under the Islamic Development Bank's international competitive bidding (ICB) or international competitive bidding – member countries (ICB/MC) procedures and for contracts for consultancy services will be announced, as they become available, in IsDB Website and EDM Website and Jornal Noticias.

Prequalification of suppliers and contractors will be required for the following contracts:

OVERHEAD TRANSMISSION LINE PACKAGE (LOT 5):

- Design, supply and construction of approximately 340 km, 400 kV Single Circuit (SC) Transmission Line from Vilanculos Substation to Chibuto Substation; *with bundled 4 x Tern conductor, one OPGW and a second shield*

wire ACS on self-supporting Y-shape tension towers and guyed V or self-supporting steel lattice towers (Lot 6).
