#### MODE OF FINANCING : IDB LOAN AGREEMENT

- 1- The Government of Cameroon has received financing from the Islamic Development Bank (IsDB) toward the cost of the Chari-Logone Integrated Rural Development Project, Phase II, and it intends to apply part of the proceeds of this financing to payments under the contract for the supply of rolling stock (one station wagon, three double cabin pick-ups and ten motorcycles).
- 2- The Project Management Unit under the Ministry of Economy, Planning and Regional Development now invites sealed bids from eligible bidders for the supply of one station wagon, three double cabin pick-ups and ten motorcycles. The delivery period is expected to be around 01 month or 30 days. The project is located in Kousseri.
- 3- Bidding will be conducted through the National competitive bidding procedures as specified in the IsDB's Guidelines for Procurement of Goods and Works under Islamic Development Bank Financing (current edition), and is open to all eligible bidders as defined in the guidelines.
