Interested consultants must provide specific information which demonstrates that they are fully qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Experience in the following area or tasks shall be the minimum requirement for the assignment:

- Project Management;
- Assess the list of equipment per institution and form a list of equipment including technical specifications of equipment;
- Prepare bidding documents;
- Carry out site supervision for installation of equipment;
- Prepare Project Progress/Completion Reports; and,
- Commission the supply and installation of the equipment.

Consultants may express interests in the forms of association, validated by an agreement among members of the association which clearly specifies the type of association, i.e. a joint-venture, intermediate forms of association, or sub consultancy.

A consultant will be selected in accordance with the procedures set out in the Guidelines for the Use of Consultants under Islamic Development Bank Financing and by the method of “Quality and Cost Based Selection (QCBS) from shortlist of firms from member countries of the Islamic Development Bank”.
