## WHO WE ARE

The Islamic Development Bank is a multilateral development bank (MDB), working to improve the lives of those we serve by promoting social and economic development in Member countries and Muslim communities worldwide, delivering impact at scale.

## MISSION

To promote comprehensive human development, with a focus on the priority areas of alleviating poverty, improving health, promoting education, improving governance, and bringing prosperity to the people.

## FINANCIAL YEAR

The IsDB's financial year used to be the lunar Hijra Year (H). However, on 1 January 2016, the financial year was changed to the Solar Hijra year starting from 11<sup>th</sup> of Capricorn (corresponding to 1 January) and ending on 10<sup>th</sup> Capricorn (corresponding to 31 December of every year).

## VISION

The Islamic Development Bank strives to become a world-class development bank, inspired by Islamic principles, that helps to significantly transform the landscape of comprehensive human development in the Muslim world and to restore its dignity

## MEMBERSHIP

The IsDB has 57 member countries across various regions. The prime conditions for membership are that the prospective country should be a member of the Organisation of Islamic Cooperation (OIC), that it pays the first instalment of its minimum subscription to the Capital Stock of the IsDB, and that it accepts any terms and conditions that may be decided upon by the Board of Governors.

## ACCOUNTING UNIT

The accounting unit of the IsDB is the Islamic Dinar (ID), which is equivalent to one Special Drawing Right (SDR) of the International Monetary Fund.

## LANGUAGE

The official language of the IsDB is Arabic, but English and French are also used as working languages.




Established as a special endowment fund (Waqf). It provides financial support to enhance the productive capacity and sustainable means of income for the poor

# IsDB Group Approvals at a Glance

## 1975 – 2024 (Q4)

- Total approvals from inception in 1975 to end of fourth quarter 2024 amounted to US\$194.8 billion.
- Net Approvals increased significantly from US\$4.4 billion in the first decade (1975-1984) to US\$93.4 billion in the last decade (2015-2024).
- A total of 1,113 operations in 76 non-member countries across five continents also benefited from the IsDB Group financing.
- The IsDB Ordinary Capital Resources (IsDB-OCR) accounted for 34.3% of the cumulative group net approvals, ITFC (42.0%) and ICD (3.9%). The remaining 19.8% are coming from other funds including APIF, ICD managed funds, ISFD, Special Assistance Operations, STI, Trust Funds, WAQF and Pre-ITFC trade (EFS, IBP, ITFO).
- Approvals for the regions are as follows:
  - Asia, Latin America & Europe: US\$87.7 billion (45.0%).
  - Middle East & North Africa: US\$63.6 billion (32.6%).
  - Sub-Saharan Africa: US\$35.5 billion (18.2%).
  - Others: US\$8.1 billion (4.1%).
- The total financing for the top ten countries represent about 60.9 percent of total IsDB Group net approvals as follows:
  - Bangladesh: US\$27.7 billion (14.2%).
  - Egypt: US\$23.1 billion (11.9%).
  - Pakistan: US\$15.8 billion (8.1%).
  - Türkiye: US\$14.0 billion (7.2%).
  - Morocco: US\$7.5 billion (3.9%).
  - Indonesia: US\$7.2 billion (3.7%).
  - Iran: US\$6.2 billion (3.2%).
  - Tunisia: US\$6.0 billion (3.1%).
  - Senegal: US\$5.6 billion (2.9%).
  - Saudi Arabia: US\$5.6 billion (2.9%).


